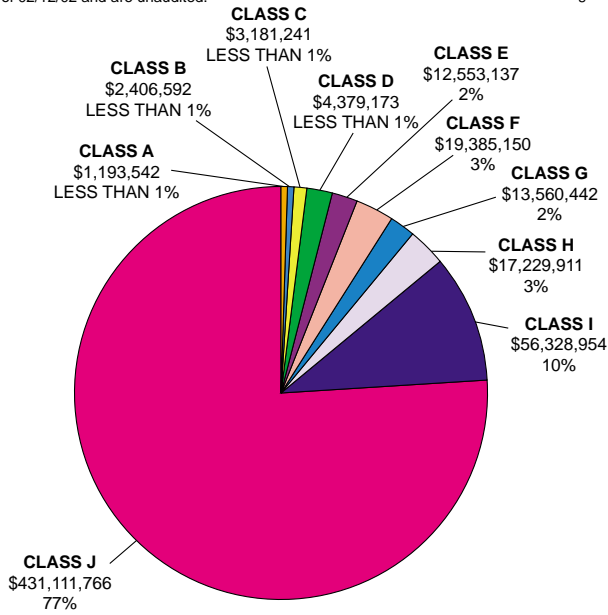

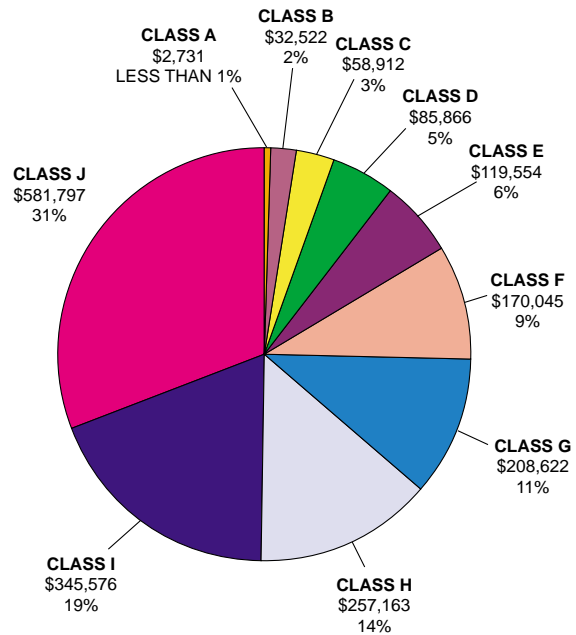
GROSS RECEIPTS BY LICENSE CLASS FOR YEAR 2001

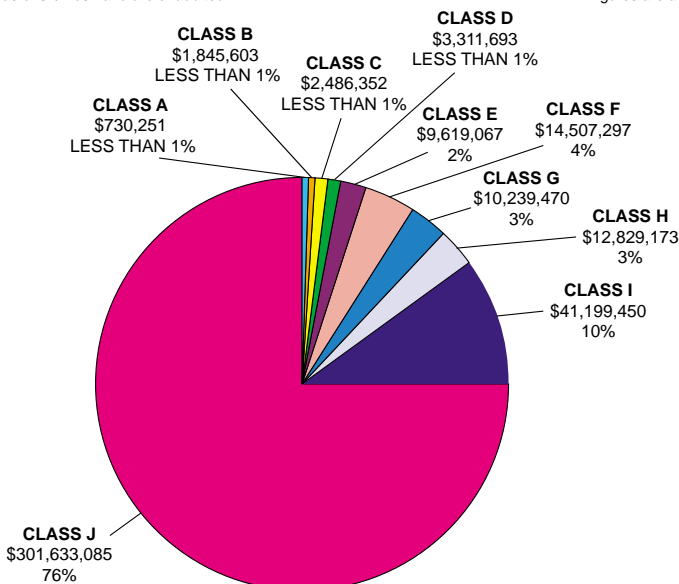
AVERAGE GROSS RECEIPTS PER ORGANIZATION FOR YEAR 2001

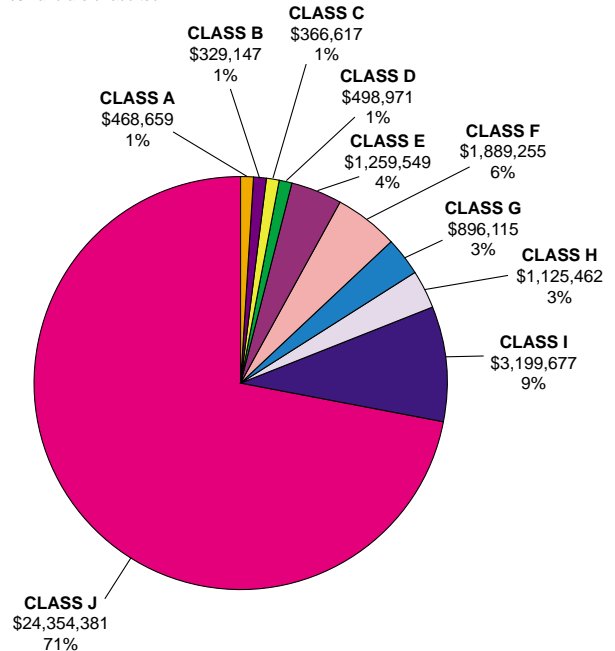
PRIZES AWARDED BY LICENSE CLASS FOR YEAR 2001
