### WHO SHOULD SUBMIT THIS SCHEDULE

This form must be submitted by a licensed manufacturer of bingo supplies, devices, and equipment, or applicant for a license wishing to post a bond issued by a surety company chartered or authorized to do business in Texas to comply with the bond required under Section 2001.204 of the Bingo Enabling Act.

KNOW BY ALL MEN THESE PRESENTS: That we, \_\_\_\_\_ as PRINCIPAL, AND \_\_\_\_\_ (Enter Legal Entity name only. DO NOT enter business address or D/B/A.)

\_\_\_\_\_ as SURETY, duly authorized unto THE STATE OF TEXAS in the sum of Ten Thousand dollars and no cents (\$10,000.00) payable at Austin, Travis County, Texas and for the payment of which, we bind ourselves, our heirs, executors, successors, and assigns, jointly and severally, by these presents.

THE CONDITION OF THIS OBLIGATION IS SUCH THAT: Whereas, the above bonded principal has been issued or has been applied for a license to manufacture bingo supplies, devices, and equipment, pursuant to the provisions of the Bingo Enabling Act, Chapter 2001, Occupations Code; and whereas, demand has been made upon the principal by the Texas Lottery Commission for security as required by the provisions of the Bingo Enabling Act to insure compliance with them. Now, if the above bonded principal complies with all the provisions of the cited statutes and regulations issued pursuant thereto respecting transactions occurring on or after \_\_\_\_\_, and its manufacturer's license is not suspended or revoked and shall fully, completely, and faithfully perform all of the conditions and provided therein, this obligation shall be null and void, otherwise it remains in full force and effect.

The surety may relieve itself from further liability at any time by giving thirty (30) days written notice of its withdrawal as surety on such bond to the Texas Lottery Commission; provided that in no event shall it be relieved from liability as respects transactions occurring before the effective date of such termination and that no recoveries on this bond or the execution of any new bonds or renewal of a license shall invalidate this or any other bond given by said applicant to the Texas Lottery Commission. Additional bond may be demanded when it is deemed by the Texas Lottery Commission that this bond is insufficient in amount. Such demand shall not effect the validity of this or any other bond given by the principal. In the event of a failure of the principal to comply with conditions and obligations of the bond and/or the requirements of the Bingo Enabling Act, Chapter 2001, Occupations Code, and/or the regulations issued pursuant thereto, and/or in the event of the revocation or suspension of the manufacturer's license of the principal, then this bond is forfeited and the state of Texas shall have the right to sue on and otherwise enforce in its face amount the obligations of this bond without first resorting to or exhausting their remedies against the property and assets of the principal or without making said principal a party to suit. Venue of any such action shall be in Travis County, Texas.

This bond shall be continuous in form from the effective date and shall be automatically extended from calendar year to calendar year and shall constitute a new or portion of a year while the bond is in force.
