



# Schedule H – Worksheet for Calculating License Fee

### WHO SHOULD SUBMIT THIS SCHEDULE

This form must be submitted by an organization requesting to amend its license to increase its number of licensed bingo occasions within the first six months of the issuance of the organization's original license to conduct bingo. The calculation on this form will determine if additional license fee will be required before the amendment may be granted.

### GENERAL INSTRUCTIONS

- Please print legibly or type.
- The fee for a license is based on your estimated gross receipts from the conduct of bingo. The new license class and fee, based on the proposed increase in the number of occasions, will be calculated using the formula below. Calculations are based on a single bingo occasion.
- Any additional license fee required should be submitted with the amendment application.
- If your original license was issued for a one year license period, refer to the One Year License Fee column on the Table of License Fees. If your original license was issued for a two year license period, refer to the Two Year License Fee column on the Table of License Fees.
- Payment must be made from your bingo bank account and made payable to the STATE COMPTROLLER.

**Note:** At the end of your first regular license period, the amount of estimated gross receipts reported in this application will be reviewed. Any deficiency of the fee due for that period must be paid prior to renewal. Any excess of the fee due will be credited to your account.
