



# Schedule AA – Certification of Association’s Offer to Lease

### WHO SHOULD SUBMIT THIS SCHEDULE

Schedule AA must be submitted by an association of licensed organizations applying for a commercial lessor license that will be leasing the bingo premises only to the members of the Association. The Texas Occupations Code, Chapter 2001, Section 2001.152(a)(1) (Act) requires an association of licensed authorized organizations to lease or offer to lease the premises to one or more other authorized organizations who are not members of the association. This certification affirms that the applicant offered to lease the premises to another licensed authorized organization that declined.

The applicant must have offered to lease the bingo premises to the authorized organization that chose to decline. Although more than one authorized organization may have been offered to lease the bingo premises, only one organization must complete this section.
