WHO SHOULD SUBMIT THIS SCHEDULE

Schedule M may be submitted by a conductor organization(s) who intends to lease the bingo premises from a commercial lessor license applicant where no amendment to their conductor's license will be required. If a valid license to lease bingo premises is currently held at the commercial lessor applicant's proposed playing location, an amendment would not be required by any organization licensed to conduct bingo at that location unless there was to be a change in the location name, playing days or times.
