WHO SHOULD SUBMIT THIS APPLICATION

This form should be used by a licensed authorized organization who wants to conduct a future temporary bingo occasion(s) without specifying a specific date(s) or time(s) of that occasion(s). The temporary bingo occasion must be conducted at the same location and within the same license period as shown on the organization's regular license.

GENERAL INFORMATION APPLICABLE TO APPROVED APPLICANTS

- All organizations must notify the commission prior to holding a temporary occasion by completing a Notice of Bingo Occasion for Approved Temporary License to Conduct Bingo form. The form must be received no later than noon the day prior to the game(s) unless the game(s) falls on a weekend or holiday when it must be received one business day prior to the game(s).
A temporary bingo occasion may only be held when an organization receives the Commission's verifications of receipt of the Notice of Bingo Occasion for Approved Temporary License to Conduct Bingo and it is posted adjacent to the applicable temporary license during the stated date and time of the occasion.
The temporary bingo occasion(s) must be held before the expiration date of an organization's regular license to conduct bingo in effect at the time of application.
The Certification of Responsibility must be signed by the Bingo Chairperson and another operator of the organization. If the Bingo Chairperson is unavailable, another officer may sign in lieu of the Bingo Chairperson. Two different persons must sign this form.
Under Charitable Bingo Administrative Rule 402.401(d)(5)(D), the Commission will not credit or refund a temporary license fee when an organization fails to timely notify the Commission of the playing date and time prior to the expiration of the regular license that was in effect when the temporary license was issued.
Each organization is eligible for 24 temporary licenses for each 12 months of their regular license period.
