

Prize Fee Vote Status

This list is only a snapshot of the status of local government votes on whether to continue receiving prize fees reflected in the Commission's records as of December 18, 2019. Section 11 of House Bill 914 (HB 914) directed the Commission to notify all eligible local governments that they were required to notify the Commission by November 1, 2019 of their vote to continue receiving prize fees. If a local government does not appear on this list, the Commission had no record that they were ever eligible to receive prize fees and thus they were not notified of the requirements to continue receiving prize fees.

As amended by HB 914, Bingo Enabling Act Section 2001.502(c) allows a local government to vote again any time after November 1, 2019 to discontinue the imposition of prize fees, in which case organizations in that jurisdiction will retain the amount previously due to the local government. This vote can take place at any time and there is no requirement that local governments notify the Commission of this vote. Therefore, the Commission encourages licensed conductors and other interested parties to exercise caution in using this list to make final decisions regarding future prize fee allocations. The proper allocation of prize fees is now the responsibility of licensed bingo conductors and their local government entities.

- Y (1)** The county or municipality notified the Commission by November 1, 2019 that they voted to continue receiving bingo prize fees, but the Commission has never allocated bingo prize fees to these counties or municipalities and the Commission has no records that these counties or municipalities voted to impose a gross receipts tax on bingo prior to January 1, 1993, which is a requirement under Tex. Occ. Code §2001.503 to receive bingo prize fees. The Commission did not notify these counties of the requirements of HB 914.
- Y (2)** The county or municipality notified the Commission after the deadline of November 1, 2019 that they voted to continue receiving bingo prize fees.
- No** The county or municipality notified the Commission by November 1, 2019 that they voted to no longer receive bingo prize fee.
- N (1)** The county or municipality notified the Commission by November 1, 2019 that they voted to continue receiving bingo prize fees, and later notified the Commission that they voted after November 1, 2019 to discontinue the imposition of prize fees.
- N(2)** The county or municipality voted no and notified the Commission after the November 1, 2019 deadline.
- NR** TLC has not received notification of a vote.
