Notification for Temporary Bingo Occasions for Regular License Organization

WHO MUST SUBMIT THIS FORM

A licensed authorized that holds a regular license has issued 48 temporary bingo licenses for each 12-month year. Before using a temporary license, the license holder shall notify the commission of the date, time and location of the bingo occasion for which the temporary license will be used. The temporary bingo occasion must be conducted at its own or licensed commercial lessor location.

GENERAL INSTRUCTIONS

- Be certain that the requested date, times and location of the temporary bingo occasion does not conflict with the playing days or times of another organization conducting bingo at the location or exceeds the maximum number of occasions per day allowed under the Texas Occupations Code, Chapter 2001.419.
- This form must be signed by the Bingo Chairperson and an officer or director of the organization currently listed on the organization's bingo license record.
- Organizations that conduct occasions not at the organization's regular license playing location may result in prize fees to different county or municipality, and the organization must file FORMID 156 Prize Fee Summary for Multiple Playing Locations while filing the quarterly report.


