- All Other License Types - must be signed by the sole owner, or by two (2) officers, LLC members, or partners of the organization.
• You will receive a confirmation letter from our office that this license has been surrendered after the request has been processed.

• The Bingo Enabling Act, Section 2001.457 requires a licensed organization, that ceases to conduct bingo, to disburse any remaining bingo funds to charitable purposes before the end of the next calendar quarter following the calendar quarter in which the organization ceases to conduct bingo (applicable to conductor licenses only.)
• The organization will receive a quarterly report at the end of the quarter in which the license was surrendered. This report must be completed and timely filed with the Commission.
