And therefore, I move that the Commission, one, delegate to Commissioner Fields the authority to coordinate with the Human Resources Director and other Commission staff as she deems necessary, without the need to further commission discussion or action, to finalize the posting for Bingo Director and post the position, and to decide on the process to screen applications, to conduct background investigations, schedule interviews, and other administrative matters related to the application process.

And then, two, have Commissioner Fields and one other commissioner of her choice, conduct initial interviews of applicants for the Bingo Director

1	position and recommend the top applicants for the
2	Commission to interview. The Commission at a later
3	posted meeting will conduct final interviews and
4	consider selecting a finalist for the position.
