TEXAS LOTTERY® APP

Digital coupons are only available through the official Texas Lottery App and require the player to initiate the coupon offer.

As the retailer, you can scan the QR code on the player's device or they can scan the code at any Texas Lottery self-service vending machine.

Just like *Lone Star Lineup*[®], there will be a confirmation screen. Confirm offer with the player and secure payment.

The terminal will print two tickets. One ticket will have the required Quick Pick purchase and the second ticket will be the free Quick Pick ticket. Give both tickets to the player.



You receive credit for the free ticket and earn 5% commission based on the full value.

FREQUENTLY ASKED QUESTIONS

Q. How do I get a copy of my 1099 for last year's commissions?

A. The IRS form 1099-MISC is mailed by January 31 of each year to retailers with commissions totaling \$600 or more, except retailers who own and operate their businesses through corporations. The IRS does not require the 1099 form to be mailed to corporations. After January 31, all Texas Lottery retailers, including those who operate via corporations, may call our Retailer Services Hotline at 800-375-6886 for commission, bonus and incentive information. You also may send a request to retailerwebhelp@lottery.state.tx.us.

Q. What do I tell a customer who can't find their favorite scratch ticket game?

A The Scratch Ticket and Retailer Locator feature online at **texaslottery.com** allows searches by city, Zip Code, smoking policy and scratch ticket game. This tool makes it easy for players to find a specific scratch ticket game in their area. Search results include contact information and a map for each location. Players may also download the Texas Lottery App and use the scratch ticket feature to find a certain scratch ticket game. Call the Customer Service Hotline (800-375-6886) for more information.
