Congratulations to 3,251 retailers who earned total base payments of \$5,216,075 in our 31st Retailer Cash Incentive Program conducted January 5 – April 4, 2020. The drawings conducted April 28 paid out an additional \$1,000,000 total to 569 of these retailers. Although the COVID-19 impact on normal business practices was significant, many retailers were still able to meet or exceed their sales goal. Their efforts and those of all our sales agents were exceptional during this difficult time.

Since the retailer incentive program was introduced September 2009, over \$187.1 million has been awarded to retailers in 31 primary and seven secondary programs. Through their participation in the programs, retailers have earned extra revenue for their businesses while generating more than \$2.4 billion in additional lottery sales to yield more than \$404.7 million in incremental revenue. We are committed to supporting and rewarding the exceptional sales efforts of all our retailers. While the current COVID-19 pandemic caused us to cancel the summer RCIP, we are currently working to introduce details of the next RCIP. Updates will be provided via terminal message as soon as details are confirmed.
