



LOTTERY SERVICES PORTAL (LSP)

The Lottery Services Portal (LSP) provides retailers with the convenience of renewing their Texas Lottery® sales license online.

Once registered in LSP, current retailers can submit a license renewal application and payment. LSP accepts payment by credit card and electronic check. Retailers can also submit changes to their current license information through LSP, including adding and deleting officers and updating location information.
