YOU ARE IMPORTANT TO US! Avoid Texas Lottery® Retailer Violations

Here is a common one to avoid:

Licensee refuses or fails to sell lottery tickets during all normal business hours of the lottery retailer. [16 TAC §401.160(g)(10)]

- It is a lottery violation to refuse or fail to sell lottery tickets during your normal business hours.
- If your location is open for business, you must have Texas Lottery tickets available for purchase.
- Refusal or failure to sell lottery games during your normal business hours can result in penalties.
- Penalties range from Warning Letters to License Suspension or Revocation.
