Make a note...

- RCIP #42 ends December 2.
- Participating retailers must be Active on December 2 to remain eligible.
- Sell *Pick 3[™]* to earn bonus drawing entries for a chance to win \$100,000 (Tier 1) or \$50,000 (Tier 2).
- RCIP #43 starts December 3.
