## **RETAILER CASH INCENTIVE PROGRAM (RCIP)**



#### #918 August 20 – September 30

• If not Active September 30, contact IGT by October 5 to claim packs.

#### #41 Ended July 29

- Drawing results on website Retailers page.
- Base & Drawing Payments September 15, pending audit.

#### #42 August 6 – December 2

- EXTENDED from 13 to 17 weeks!
- INCREASED BUDGET from \$8.5 million to \$15 million + \$1 million for drawings!
- Minimum Sales Goal will not be less than \$95,000.
- Goals based on projected overall slowing of sales.

## TEXAS LOTTERY® APP

The Texas Lottery App can direct players to your store if you have the scratch ticket game they seek!

Players may tap the GAME/RETAILER LOCATOR button to search for retailers that have the desired scratch game in inventory and in Active or Confirmed status.

Results are displayed on an interactive map. As the player swipes through the retailer list, the map position associated with the displayed retailer is highlighted with a star.

Players may get directions by calling the retailer or using their phone navigation app.



## **CONSUMER PROTECTION**



#### YOU ARE IMPORTANT TO US! Avoid Texas Lottery Retailer Violations

#### Here is a common one to avoid:

#### Licensee intentionally or knowingly sells a ticket at a price the licensee knows is greater than the price set by the executive director. [16 TAC §401.160(h)(22)]

- Texas Lottery retailers may not charge more than the price printed on the ticket.
- Retailers may not charge a fee for lottery ticket purchases using a debit card.
- Retailers may require a minimum dollar amount for debit card purchases if the minimum applies to all products, but may not require a minimum amount for purchases of only lottery tickets.
- Penalties range from License Suspension to Revocation.
