If a game closes due to Zero Top Prizes, retailers may sell any of the other promotion games to reach the pack threshold. Retailers must be Active on November 1 to be eligible for free packs and drawing entries. If the Texas Lottery identifies irregularities in pack settlements or returns, the agency may disqualify a retailer from participating in incentives and take action against the retailer's license.

#### DRAWING

- Pending audit, the drawing is planned for **November 18**.
- Pending audit, drawing payments to retailers' lottery bank sweep account are planned for **December 19**.
- Only one drawing prize per location. A chain with multiple locations may win at more than one location.
- If there are not enough unique retailers with entries to award all the prizes there may be fewer winners for the drawing.

#### FREE PACKS

- Retailers who qualify for free packs, but do not maintain their Texas Lottery® license after **November 1** must contact their Brightstar district office by **November 6** to claim packs.
- Results may be available after **November 25**, pending audit.
- Tickets will be delivered by **January 13**.

\*The Texas Lottery may substitute a different scratch ticket game of equal value for the game listed.

\*\*Packs must be in Settled status and have a validation recorded in the Texas Lottery gaming system to qualify for the promotion.

## TRACK YOUR PROGRESS



Use the chart below to track your pack settlements and award packs/entries. To qualify for a pack of **#2700 BREAK THE BANK\***, contest packs must be Settled\*\* **September 21 – November 1**, and have at least one validation per pack recorded in the gaming system on or before **November 1**. Terminal and Retailer Wizard reports for secondary RCIP #929 will not be available before **November 25**.

To track Settled packs, use the Settled Pack Report on your terminal.

**Step 1:** On the HOME screen, press **Scratch Ticket Menu**

*Step 2:* Press **Inventory Reports**

### Step 3: Press **Settled Pack**

**Step 4: Select WEEK ENDING DATE**

Step 5: Enter game #

### Step 6: Press **Send**

**Step 7:** Settled Pack Report displays and can be printed

## \*\*Settlement Method Definitions

%CSH	70% of low-tier winners cashed	Confirms that there was a validation on the pack.
RTL	Retailer settles pack	Confirm that a validation has occurred by contacting your Lottery Sales Representative or Texas Lottery® Retailer Services at 800.375.6886.
DAYS	45 or 21 day auto-settlement	Confirm that a validation has occurred by contacting your Lottery Sales Representative or Texas Lottery Retailer Services at 800.375.6886.
