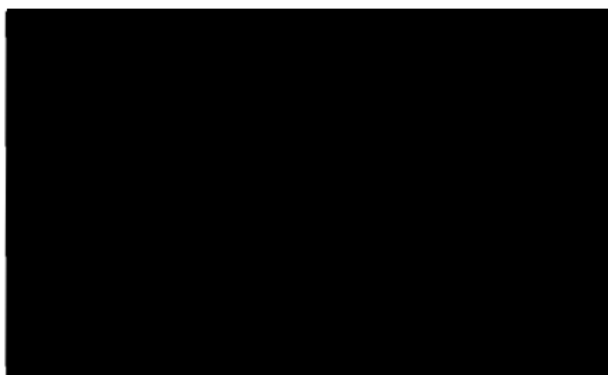

6.2 JAWS LICENSE AND PROMOTION DETAILED REQUIREMENTS

\$1,000,000 JAWS CHALLENGE PROMOTION

These detailed requirements apply to the \$1,000,000 JAWS CHALLENGE Promotion (the **"Promotion"**), a second-chance drawing promotion for the JAWS scratch ticket game identified in Section 1 below (the **"Game"** or **"Eligible Game"**). These requirements shall be part of the working papers for the Game.

1. PROMOTION DESCRIPTION

The Texas Lottery Commission (**"TLC"**) shall produce a JAWS scratch ticket game, which will feature the JAWS licensed property, to be printed by Pollard Banknote Limited (**"PBL"**), with the following name and price point, in the designated ticket quantity on or about the launch dates shown below:

- (a) \$5.00 **"JAWS"** (Game Number 2657) seven million two hundred thousand (7,200,000) tickets launching June 2, 2025;

PBL has agreed to grant the TLC the use of the JAWS licensed property as defined in Section 2.

PBL has contracted with Atlas Experiences, LLC (**"Atlas"**) to perform certain tasks associated with the Promotion. For avoidance of doubt, PBL shall be ultimately responsible to ensure fulfillment.

PBL, through Atlas, will host the Promotion microsite. Players may use the Texas Lottery® website/Luck Zone (accessible through the microsite) or the Luck Zone feature of the Texas Lottery App to enter any non-winning tickets from the Game in one (1) of four (4) promotional drawings described in Section 4 below (the **"Trip Prize Drawings"**) for a chance to win one (1) of forty (40) trip prizes (the **"Trip Prizes"**) for a trip to Austin, Texas to participate in the Promotion.

2. LICENSED PROPERTY

DEFINITIONS:

- a) The term **"Property"** shall include the use of the classic 1975 live-action feature-length motion picture entitled **"JAWS"**
- b) **"Game"** means the scratch ticket game issued by the TLC bearing the Property described above, also referred to as the Texas Lottery JAWS scratch ticket game.

TRADEMARK and OTHER REQUIREMENTS:

- a) PBL reserves the right to modify trademark elements prior to final approval of all creative elements.
- b) PBL hereby grants to the TLC the limited, non-transferable and non-sublicensable right and license to promote, advertise and sell scratch ticket games bearing the Property within the state of Texas, subject to terms herein. Upon termination of the license (unless terminated for breach by TLC), the TLC shall have the right to continue to market and sell the scratch tickets which are on hand or in process at the time of such expiration or termination for a period of one hundred and eighty (180) days from the announced end of the Game; provided that, the TLC may continue to reproduce, use, and make copies

of this Property solely for historical, archival, or illustrative purposes, including but not limited to agency reports, open records responses, legislative document requests, and other similar uses that document the existence and performance of the Game as a business initiative of the TLC.

- c) The TLC shall indicate that licensing rights for scratch ticket games that include Pollard Banknote Licensed Properties have been obtained from PBL in any press releases relating to any such games issued by the TLC.
- d) The TLC shall submit to PBL all advertising and promotional materials for approval, not to be unreasonably withheld.
- e) Copyright notices shall be included on all tickets, advertising and promotional materials as appropriate.
- f) The following legal line and seal shall be included on the back of all tickets and on all advertising and promotional materials, space permitting:

3. ALLOCATION FOR PRIZE FULFILLMENT, PROMOTION SERVICES AND PROMOTIONAL SUPPORT

The TLC shall allocate a total of one million seven hundred three thousand five hundred dollars (\$1,703,500), as indicated below, for PBL/Atlas to fulfill all Trip Prizes and to provide other Promotion-related services, manufacturing, and marketing support. This amount reflects an allocation as follows:

- a) A license fee based upon actual game sales in an amount not to exceed five hundred and forty thousand dollars (\$540,000.00) to be invoiced and paid as provided in Section 9 below.
- b) A program fee amount of one million eighty-three thousand five hundred dollars (\$1,083,500) to be invoiced and paid as provided in Section 9 below.
- c) Trip prize amounts detailed in the table below totalling eighty thousand dollars (\$80,000) to be invoiced and paid as provided in Section 9 below.

PBL and/or Atlas shall provide the following items:

- a) Production and promotional marketing, and advertising as described further herein;
- b) Fulfillment and hosting of forty (40) Trip Prizes valued at two thousand (\$2,000) each. The total value for all forty (40) Trip Prizes plus fulfillment is eighty thousand dollars (\$80,000).

- c) Fulfillment of Trip Prize amenities and events, including the \$1,000,000 JAWS Game Show (see section 5 below) with an overall guaranteed total of one hundred ten thousand dollars (\$110,000) in Cash Giveaways, and a one million dollar (\$1,000,000) insured cash prize.
- d) The TLC shall have no liability related to any Trip Prize, or any cash prizes won in any cash prize giveaway, including any financial or tax liability.

4. TRIP PRIZE DRAWINGS

- a) TLC shall conduct four (4) Trip Prize Drawings to award a total of ten (10) Trip Prizes in each of the four (4) Trip Prize Drawings, for a total of forty (40) Trip Prizes. After all related validation procedures by the TLC are complete for each of the Trip Prize Winners, the TLC will notify PBL and title to the awarded Trip Prize shall immediately pass to the winner. PBL/Atlas shall fulfill the Trip Prizes as provided in Section 7 below.
- b) Each Trip Prize is valued at two thousand dollars (\$2,000). PBL shall provide an IRS Tax Form W-2G or 1042S to the Trip Prize Winners for the value of the Trip Prize.
- c) PBL/Atlas will withhold and pay the taxes associated with any Cash Giveaway prizes awarded during the Trip Prize events to the IRS on behalf of each event cash prize winner. The TLC shall have no liability related to any Trip Prize or event cash prizes won, including any financial or tax liability.
- d) A player may win only one (1) Trip Prize per Drawing, but a player is eligible to win a Trip Prize in each of the four (4) Drawings.
 - i. Any person who wins more than one Trip Prize may either claim one (1) or more of such Trip Prizes won (and thereby be responsible for all taxes on all such prizes claimed) or decline to claim any of the additional Trip Prizes. Each Trip Prize that goes unclaimed by a Trip Prize Winner shall be awarded to an alternate, and the alternate shall be responsible for all taxes on that Trip Prize.

If a Trip Prize Winner claims more than one Trip Prize, the Trip Prize Winner may personally participate in the Cash Giveaway event contest in one (1) Finalist position only and shall assign a Proxy to play on his/her behalf, and a Guest, for each additional Trip Prize claimed. A Proxy must be eighteen (18) years of age or older. All Cash Giveaway prizes won by the Proxy shall be awarded to the Trip Prize Winner (less applicable tax withholdings). If the Trip Prize Winner does not timely assign a Proxy for each additional Trip Prize, or Cash Giveaway prize, PBL/Atlas shall assign a Proxy as applicable.

5. TRIP PRIZE SPECIFICATIONS

The Trip Prize event shall take place approximately eighteen (18) months after the scratch ticket launch at the South Lamar Alamo Drafthouse in Austin, Texas. If the Trip Prize event cannot take place on these dates, the event shall be rescheduled to take place on alternative dates, to be approved by the TLC. Should the date change for any reason outside of PBL/Atlas's control, PBL/Atlas shall work with the Trip Prize
